

WEBSITE PRIVACY POLICY

Balsamo S.r.l. ("we" or "us" or "our" or "the Data Controller") respects the privacy of our users ("user" or "you"). This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website balsamo.care, including any other media form, media channel, mobile website, or mobile application related or connected thereto (collectively, the "Site"). Please read this privacy policy carefully. If you do not agree with the terms of this privacy policy, please do not access the site.

We reserve the right to make changes to this Privacy Policy at any time and for any reason. We will alert you about any changes by updating the "Last Updated" date of this Privacy Policy. Any changes or modifications will be effective immediately upon posting the updated Privacy Policy on the Site, and you waive the right to receive specific notice of each such change or modification.

You are encouraged to periodically review this Privacy Policy to stay informed of updates. You will be deemed to have been made aware of, will be subject to, and will be deemed to have accepted the changes in any revised Privacy Policy by your continued use of the Site after the date such revised Privacy Policy is posted.

COLLECTION OF YOUR INFORMATION

We may collect information about you in a variety of ways. The information we may collect on the Site includes:

Personal Data

Personally identifiable information, such as your name, shipping address, email address, and telephone number, and demographic information, such as your age, gender, hometown, and interests, that you voluntarily give to us when you register with the Site or when you choose to participate in various activities related to the Site, such as online chat and message boards. Derivative Data

By Law or to Protect Rights

share your information as permitted or required by any applicable law, rule, or regulation. This includes exchanging information with other entities for fraud protection and credit risk reduction.

Third-Party Service Providers

We may share your information with third parties that perform services for us or on our behalf, including payment processing, data analysis, email delivery, hosting services, customer service, and marketing assistance.

Marketing Communications

With your consent, or with an opportunity for you to withdraw consent, we may share your information with third parties for marketing purposes, as permitted by law.

WEBSITE INTEGRATED CHAT

The legal basis of the processing are identified in the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract (article. 6.1.b) of the Regulation) and in the compliance with a legal obligation to which the Data Controller is subject (article 6.1.c) of the Regulation).

Your Personal Data may be shared with:

- natural persons authorized by the Data Controller to process Personal Data, due to the performance of their work duties (eg. employees and system administrators, etc.);
- third parties for the performance of economic activities, some of which act as Data Processors under Article 28 of the Regulation;
- persons, bodies or authorities to whom/which it is mandatory to communicate your Personal Data pursuant to legal provisions or orders from the authorities.

With regard to any transfer of personal data to third countries, the Data Controller informs that the processing will take place according to one of the means permitted by the applicable law, such as the consent of the data subject, the execution of a contract concluded between the data subject and the data controller, or the execution of pre-contractual measures taken at the request of the data subject; the conclusion or execution of a contract concluded between the data controller and another natural or legal person in the interest of the data subject; the adoption of Standard Contractual Clauses approved by the European Commission, appropriate safeguards (e.g. EU-US Privacy Shield), adequacy decisions. With reference to the aforementioned purposes, the processing of Personal Data will be carried out by manual and informatic means, in compliance with the purposes so as to protect privacy and security of personal data and to ensure the compliance to specific legal obligations.

You have the right to ask the Data Controller, at any time, to access your Personal Data, correct or delete them, you have the right to object to the processing, to request the limitation of processing in the cases provided for by Article 18 of the Regulation, to revoke the consent already given, at any time, under Article 7 of the Regulation, to obtain in a structured, commonly used and machine-readable format, the data concerning you in the cases provided for by Article 20 of the Regulation and to lodge a complaint with the competent supervisory authority, pursuant to Article 77 of the Regulation, if you believe that your personal data have been unlawfully processed.

You can make a request in order to object to the processing of your data, under Article 21 of the Regulation, in which giving evidence of the reasons that justify the opposition: Data Controller will evaluate your request, that shall be not accepted in case of the existence of compelling legitimate interest for processing overriding your interests or rights and freedoms.
